#### Who Can Participate?

Businesses, individuals and couples in Pennsylvania with state income tax liability. Minimum donation: \$3,500. Maximum donation: \$750,000



#### Choose how your taxes are spent

Why give your taxes to the state when you could keep them in your community? Participating in EITC allows this. You receive 90% of your donation back as a non-refundable state income tax credit. The remaining 10% qualifies as a federal tax deduction



#### Why Should I Participate?

You impact lives by providing tuition assistance to families in need, with dollars you would otherwise pay to the state



## Turning Taxes into Scholarships

### What is EITC?

The PA Educational Improvement Tax Credit (EITC) program allows businesses and individuals to redirect their current year taxes to scholarship orgs and private schools

Launched in 2001, 100% of taxpayer donations to eligible schools provide need-based scholarships for local low- and mid-income students. MVCS is recognized by the state of PA as an eligible school

### How it Works

EITC provides companies and individuals with a 90% non-refundable state income tax credit for donations of at least \$3,500. The remaining 10% qualifies as a federal tax deduction. 100% of your EITC donation funds MVCS scholarships

#### Example:

- Donation: \$6,000
- PA State Income Tax Credit: \$5,400
- Federal Tax Deduction: \$600 (\$144 tax reduction @ 24% tax bracket)
- Total Tax Reduction: \$5,544

**Cost of \$6,000 Donation to you: \$456**

## PA Educational Improvement Tax Credit Program (EITC)

### 4 Easy Steps

#### Step 1: Sign Up

Sign a simple one-page Intent to Pledge Form with MVCS (This is not a formal contract, it merely kickstarts the process of securing your state tax credits)

#### Step 2: Send Your Gift

We request your donation check after your tax credits are approved by the state (generally 30-60 days from pledge)



**Step 4: Receive Tax Credit**  
You receive your non-refundable PA state income tax credit for 90% of your EITC donation (Remaining 10% is an eligible Federal Tax Deduction)

**Step 3: Receive Tax Forms**  
We will send you a K-1 Donation Form for your tax records (February)
